

ARTICLES OF INCORPORATION

DBA: Peers 2 Peers Co.; DBA: Peers 2 Peers Quick Response Unit

(Under the Montana Business Corporation Act)

- I. The name of the corporation is: "The Hope Health Alliance, Inc."
 - a. The corporation is a general for profit corporation with intention to become non-profit.
 - b. There is to be, at the least, the following '**Doing Business As**':
 - i. "Peers 2 Peers Co." (Community Mental Health Center)
 - ii. "Peers 2 Peers Quick Response Unit" (home crisis response)
 - iii. "The Hope Clinic" (primary healthcare)

- II. The (initial) principal address for business of the corporation is 314 White House Lane, P.O. box 1195, Missoula, MT 59802.
